

## HEART WALK VOLUNTEER RELEASE AND INDEMNIFICATION

1. VOLUNTARY PARTICIPATION. I acknowledge that I am volunteering for the American Heart Association, Inc.'s ("AHA") Heart Walk and understand that I will not be paid for my services and will not be covered by any insurance of the AHA. I further agree that my volunteering may be terminated at any time by the AHA or by me.

2. ASSUMPTION OF RISK. Volunteering at Event involves walking, lifting, standing, jumping, cheering – potentially hazardous activities that may include risks such as, but not limited to, falling, injury, tripping, contact with participants, effects of weather, traffic and conditions of the road. In consideration of being allowed to volunteer, I hereby expressly assume all risks, including personal injury and death and damage to my property arising out of my volunteering. I am solely responsible for my own health and safety and represent and warrant that I am physically fit and able to volunteer for the AHA. I further agree that I will not operate any automobile for any purpose relating to my volunteering.

3. RELEASE AND INDEMNIFICATION. I agree for myself, my heirs, executors and administrators to not sue and to release, indemnify and hold harmless, the American Heart Association, Inc., its affiliates, officers, directors, volunteers and employees and all sponsoring businesses and organizations and their agents and employees ("Released Parties"), from any and all liability, claims, demands and causes of action whatsoever, arising out of my volunteering and related activities, whether it results from the negligence of any of the above or from any other cause.

4. MEDICAL RELEASE. I hereby release and forever discharge the Released Parties from any claims whatsoever that may arise on account of any first aid or medical treatment including not getting medical attention in connection with my volunteering.

5. MEDIA RELEASE. I consent to the unrestricted use by the AHA of any photographs, video and audio recordings of me created in connection with my volunteering and hereby convey to the AHA all title, rights and interests thereto including but not limited to any royalties or other benefits.

6. INTERPRETATION. California law shall control this agreement. The foregoing release and indemnification agreement shall be as broad and inclusive as is permitted in California. If any portion of it is held invalid, the balance shall continue in full force and effect.

7. VOLUNTARY AND PERMITTED EXECUTION. By signing this agreement, I certify that I have carefully read this agreement and fully understand and accept its contents. I further acknowledge that I am under eighteen and hereby deliver the consent of my parent or guardian.
