American Heart Association 2022 Broward Heart Walk

The 2022 **Broward Heart Walk ("Event") Sweepstakes** ("Sweepstakes") is a volunteer-based program conducted by American Heart Association, Inc. ("AHA" and/or "Sponsor") in support of its mission to be a relentless force for a world of longer, healthier lives. These rules (the "Rules") apply to all participants. The Sponsor will make all determinations as to whether the Rules have been complied with, and the decision of the Sponsor as to any issue is final.

Sponsor: AHA is the Sponsor of this Sweepstakes.

<u>Entry</u>: Participants can enter the Sweepstakes during the Sweepstakes Period by identifying themselves to AHA as an "Executive with Heart Member" and by raising \$5,000 or more for the Broward Heart Walk. Limit 1 entry per person.

<u>Time</u>: The Sweepstakes starts at 12:01 a.m. on July 1, 2021 (all times Eastern Time) and ends at 11:59pm on March 13, 2022 (the "Sweepstakes Period"). All entries must be received by AHA during the Sweepstakes Period.

<u>Prizes</u>: Suite access at the next Florida Panthers vs. Detroit Red Wings game for Winner and a guest with an approximate value of \$175/seat.

The actual value may be more or less. The odds of winning are dependent on the number of entries.

<u>Determination of Winner</u>: There will be up to 25 winners (each a "Winner") of the Sweepstakes. Sponsor will use a random number generator to select the Winners from eligible Participants. Winners will be announced on March 14, 2022.

<u>Taxes:</u> The value of either Prize is includible in the Winner's income. Sponsor may be required to report the value of a Prize to the Internal Revenue Service. A Winner is responsible for paying all federal, state, and local income and other applicable taxes due in connection with receipt of a Prize, if any.

Failure to execute and return the Winner Notification Agreement and accept a prize, timely, and pursuant to the terms stated therein, will result in such Winner's automatic forfeiture of Winnter's prize with no substitution or alternative prize available.
