

**American Heart Association
2022 Broward Heart Walk Top Walker**

The 2022 **Broward Heart Walk Top Walker (“Event”) Sweepstakes** (“Sweepstakes”) is a volunteer-based program conducted by American Heart Association, Inc. (“AHA” and/or “Sponsor”) in support of its mission to be a relentless force for a world of longer, healthier lives. These rules (the “Rules”) apply to all participants. The Sponsor will make all determinations as to whether the Rules have been complied with, and the decision of the Sponsor as to any issue is final.

Sponsor: AHA is the Sponsor of this Sweepstakes.

Eligibility: **No purchase or donation is necessary to participate in the Sweepstakes.** Participation is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older as of the date of entry who are attending the Event. Employees, officers, or directors of AHA and their immediate family members are not eligible to win.

For this purpose, “immediate family” includes the spouse, parents, grandparents, great-grandparents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This definition also includes a) “step” and adoptive relationships, b) individuals for whom an employee is the current legal guardian and c) individuals who are not legally related but who reside with an employee. THE SWEEPSTAKES IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Entry: Participants can enter the Sweepstakes during the Sweepstakes Period by identifying themselves to AHA as an individual/walker who is registered on the Heart Walk website and raises \$1,000 or more for the Broward Heart Walk. Limit 1 entry per person.

Time: The Sweepstakes starts at 12:01 a.m. on July 1, 2021 (all times Eastern Time) and ends at 11:59pm on March 13, 2022 (the “Sweepstakes Period”). All entries must be received by AHA during the Sweepstakes Period.

Prizes: A 2-night hotel accommodations for (2) adults and (2) one-day badges for either Thursday, April 7, 2022 or Friday, April 8, 2022 at The Masters Tournament in Augusta, GA with an approximate value of \$5000.

The actual value may be more or less. The odds of winning are dependent on the number of entries.

Determination of Winner: There will be 1 winner (each a “Winner”) of the Sweepstakes. Sponsor will use a random number generator to select the Winner from eligible Participants. The Winners will be announced on March 14, 2022.

Taxes: The value of either Prize is includible in the Winner’s income. Sponsor may be required to report the value of a Prize to the Internal Revenue Service. A Winner is responsible for paying all federal, state, and local income and other applicable taxes due in connection with receipt of a Prize, if any.

Consent to Publicity. By entering the Sweepstakes, each Winner consents to Sponsor’s use of the Winner’s name, voice, likeness, Social media handles (including but not limited to Twitter, Instagram, and Tiktok) and/or photograph in any publicity, publications, promotional and marketing material, advertising, and any other print materials, web pages, electronic or other communications published or distributed by AHA without compensation and without notice and agrees to sign an agreement to this effect.

Miscellaneous Conditions: In the event that the operation or administration of the Sweepstakes is impaired or



prevented in any way for any reason, including, but not limited to fraud, change of condition, or other technical problems, the Sponsor may in its sole discretion, either: (a) terminate the Sweepstakes; (b) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Rules; and/or (c) substitute other prizes for any prize set forth in these Rules that becomes unavailable for any reason. The Sponsor reserves the right in its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes or acting in violation of these Rules. Failure to execute and return the Winner Notification Agreement and accept a prize, timely, and pursuant to the terms stated therein, will result in such Winner's automatic forfeiture of Winner's prize with no substitution or alternative prize available.

Sponsor is not responsible for: (i) electronic transmissions that are lost, late, stolen, incomplete, damaged or misdirected; (ii) any problems or technical malfunctions, errors, omissions, deletions, defects, communication failures or (iii) causes beyond the Sponsor's reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Sponsor will not be responsible if weather conditions, event cancellations, acts of God, pandemic, or other circumstances beyond its control prevent the Sweepstakes from taking place.
