OSCAR MUNOZ

On October 15, 2015, Oscar Munoz began his day like any other—training for a triathlon and settling into his role as CEO of United Airlines. Just 37 minutes later, he woke up in the ICU after suffering a catastrophic cardiac event. His heart was so severely damaged that survival would require a heart transplant. What followed were months of uncertainty, waiting and hope—until, on January 5, 2016, his birthday, Oscar received the “miracle call” that gave him a second chance at life.

Oscar’s survival was made possible by awareness, timely emergency care and lifesaving medical advances—each supported by the American Heart Association. But not every story ends this way. While waiting for his transplant, Oscar befriended a United flight attendant, Fernando Falcone, who never received his miracle call. Fernando died while on the transplant waiting list. That is why we gather tonight: to honor survivors, remember those lost and accelerate the work still needed. Together, with the American Heart Association and supporters like you, we can help make surviving heart disease the expectation—not the exception.

By coming together tonight, we honor those who save lives and commit ourselves to filling more seats at family tables across our communities—right here in the Bay Area.
